SUBMISSION REQUIREMENTS

1. All entries must consist of: i. Up to three (3) A3 posters mounted on foam core boards in 'landscape' format; ii. A brief synopsis of the design concept in not more than 100 words; iii. Completed Submission Form; iv. One (1) CD soft copies for the above item (i ii & iii), minimum 300 dpi resolution; v. The entry fee of RM 50 per submission;

2. Participants are allowed to submit any number of entries provided that each entry is accompanied by a separate submission form and entrance fee;

3. There must not be any mark or identification of the Entrants on any of the Submission Materials.
