# PAM - TAN SRI Ar. CHAN SAU LAI ARCHITECTURE AWARD

## AWARD BRIEF, RULES AND CONDITIONS



## 1.0 OBJECTIVE

1.1 The objective of the Awards is to recognise outstanding achievements by students of architecture in design, and to introduce these students to the profession and the industry.

#### 2.0 AWARDS PRIZES

- 2.1 The Awards will have three categories of prizes:-
  - 2.1.1 One finalist will be judged as the Awards Winner to receive the prize money of RM25,000, and the Winner Certificate,
  - 2.1.2 Four finalists will receive the Commendation prizes being prize money of RM5,000 each, and a Commendation Certificate, and
  - 2.1.3 Five finalists will receive prize money of RM1,000 each, and a Finalist Certificate.
  - 2.1.4 The Jury may award less than four Commendation prizes.

## 3.0 AWARDS SUBMISSION

- 3.1 There will be two stages of submission:-
  - 3.1.1 In Stage One:-
    - 3.1.1.1 Each entrant may submit not more than three design projects undertaken within an architecture course, for judging.
    - 3.1.1.2 Each design project must be described and presented in not more than two A3 images.
    - 3.1.1.3 All submissions must be made electronically to the designated email address or website.
    - 3.1.1.4 Up to ten finalists, and one design project of each finalist, will be selected by the Awards Jury for Stage Two judging.

## 3.0 AWARDS SUBMISSION (CONTINUE)

- 3.1.2 In Stage Two:-
  - 3.1.2.1 Each finalist must submit two A1 images, and any other additional material of the selected design project.
  - 3.1.2.2 All submissions must be made electronically to the designated email address or web site.
  - 3.1.2.3 The Jury may require a finalist to present the design project in person, or by tele-conference.

### 4.0 AWARDS JURY AND CONVENER

- 4.1 A Convener shall be nominated from amongst members of PAM Education Fund (PEF) Board of Management at the commencement of each cycle.
- 4.2 The Jury shall comprise of 5 members comprising of PAM President, Tan Sri Ar. Chan Sau Lai as founder of the Awards, or his nominee; Ar Boon Che Wee, as co-founder of the Awards, or his nominee; and two eminent architects.
- 4.3 Judging at Stage One will require a quorum of minimum three members of the Jury, and judging at Stage Two will require a full quorum of all five members of the Jury.
- 4.4 Any decision of the Jury shall be by a simple majority and shall be final.
- 4.5 PEF may nominate other Council or PEF Board of Management members to replace PAM President, PAM Education Committee Chairman and/or member of the Jury, at any time and for any stage of judging.

## 5.0 AWARDS PROGRAMME

The Awards programme is as follows:

- 5.1 Announcement of the cycle of the Awards : October December.
- 5.2 Invitation and Opening for submission : January February
- 5.3 Closing of Stage One Submission:
  In the month of March or not less than three weeks and not more than four weeks of the opening for submission of Stage One.
- 5.4 Judging of Stage One Submission, Announcement of Finalists, and Opening of Stage Two Submissions:
  In the month of April or within three weeks of closing for submission of Stage One.
- 5.5 Closing date for Stage Two Submission:
  In the month of May or not less than three weeks and not more than four weeks of the opening of submission for Stage Two

## 5.0 AWARDS PROGRAMME (continue)

- 5.6 Judging of Stage Two Submission and announcement of the final results of the awards:
  - In the month of June or within three weeks of closing of Stage Two Submission.
- 5.7 Presentation of the prizes
  In the month of July or within three months of the announcement of the Awards' final results.
- 5.8 PAM reserves the right to vary the programme.

### 6.0 ELIGIBILITY

- 6.1 The Award is open to:
  - 6.1.1 Malaysian students who have just completed an architecture course in the immediate preceding year, in Malaysia or abroad.
  - 6.1.2 Must be a current PAM member of any category or have applied as PAM member of any category. PAM student membership is free.
  - 6.1.3 Past Awards winners are not eligible to participate again.
  - 6.1.4 Previous finalists including recipients of commendation prizes are eligible to submit.
  - 6.1.5 Individual or group project is eligible but only one prize will be awarded to each winning project.
  - 6.1.6 Schools of architecture may submit on behalf of the students.

## 7.0 COPYRIGHT AND RIGHT OF OWNERSHIP

7.1 All submission materials shall remain the property of PAM, and PAM retains the rights to publish the materials in any PAM media or any other media authorized by PAM, without any payment to any party, and in doing so, will undertake to give due credit and acknowledgement to the authors concerned.
