GUIDELINE ON DEVELOPMENT OF CENTRALISED LABOUR QUARTERS (CLQ) AND APPLICATION PROCEDURE FOR TEMPORARY LABOUR QUARTERS (TLQ)

I would like to inform that the Ministry of Housing and Local Government (*Kementerian Perumahan dan Kerajaan Tempatan* – KPKT) and PLANMalaysia, have approved the following Procedure/Guildeline:

i. Circular for Application Procedure For the Provision of Short Term Labour Quarters

Prosedur Permohonan Bagi Penyediaan Penginapan Pekerja Secara Jangka Pendek – Attachment 1; and

- ii. Planning Guideline for Centralised Labour Quarters (CLQ)
 Garis Panduan Perancangan Penginapan Pekerja Berpusat Attachment 2.
- 2. Both the Circular on Short Term Labour Quarters and Guideline on CLQ have been approved by *Majlis Negara bagi Kerajaan Tempatan* (National Council for Local Government). The Circular and Guildeline were prepared as reference for Government agencies, developers, employers, manufacturers and operators to provide safe and conducive accommodation for their workers.
- 3. The Circular on Short Term Labour Quarters outlines six (6) alternatives for temporary labour quarters that encompass existing residential, commercial and industrial areas. It is a short-term alternative for employers to provide temporary accommodation of workers; the procedure is applicable for a period of three (3) years (2021-2023). To facilitate the provision of centralised labour quarters in Malaysia, the Guildeline on CLQ issued by KPKT and PLANMalaysia covers accommodation in new and brownfield areas that will assist employers and facilitate the industry in their efforts to ensure orderly and sustainable development and operation of workers' accommodation.

5. Enclosed is the Circular on Application Procedure for Short Term Labour Quarters and Guideline on Development of CLQ.
